ORDER GRANTING INTERVENTION
OF ILD TELECOMMUNICATIONS, INC.

BY THE COMMISSION:

By petition filed March 17, 2009, ILD Telecommunications, Inc. (ILD), in accordance with Rules 28-105.0027 and 25-22.039, F.A.C., has requested permission to intervene in this proceeding. ILD states that as a third-party billing aggregator, it has a substantial and material interest in the matters raised in this proceeding because a determination by the Commission as requested in the petition for declaratory statement would substantially and adversely affect ILD's ability to aggregate charges for its service providers and then to have those charges billed by the local exchange companies under existing agreements.

Having reviewed the petition, it appears that ILD's substantial interests may be affected by this proceeding. There has been no response filed in opposition to this request. Therefore, ILD's petition shall be granted. Pursuant to Rule 25-22.039, F.A.C., petitioner takes the case as it finds it.

Therefore, it is

ORDERED by the Florida Public Service Commission that ILD Telecommunications, Inc.'s petition for leave to intervene is hereby granted. It is further



NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.569(1), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Mediation may be available on a case-by-case basis. If mediation is conducted, it does not affect a substantially interested person's right to a hearing.

Any party adversely affected by this order, which is preliminary, procedural or intermediate in nature, may request: (1) reconsideration within 10 days pursuant to Rule 25-22.0376, Florida Administrative Code; or (2) judicial review by the Florida Supreme Court, in the case of an electric, gas or telephone utility, or the First District Court of Appeal, in the case of a water or wastewater utility. A motion for reconsideration shall be filed with the Office of Commission Clerk, in the form prescribed by Rule 25-22.0376, Florida Administrative Code. Judicial review of a preliminary, procedural or intermediate ruling or order is available if review of the final action will not provide an adequate remedy. Such review may be requested from the appropriate court, as described above, pursuant to Rule 9.100, Florida Rules of Appellate Procedure.
