**Re: Cleartel Telecommunications, Inc., IDS Telecom Corp., nii communications, Ltd. and Supra Telecommunications and Information Systems, Inc. Request to Surrender Their Certificates and Registrations**

Dear Ms. Cole:

Cleartel Telecommunications, Inc. d/b/a NOW Communications, Inc. also d/b/a VeraNet Solutions ("Cleartel"), IDS Telecom Corp. d/b/a Cleartel Communications ("IDS"), nii communications, ltd. ("nii"), and Supra Telecommunications and Information Systems, Inc. ("Supra"), (together "Companies"), requests that the Florida Public Service Commission ("Commission") cancel their Certificates granted by, and rescind all tariffs on file with, the Commission to provide local exchange and interexchange telecommunication services, effective immediately.

In Florida, the Companies hold the following Certificates and IXC Registrations:

Cleartel holds CLEC Certificate No. 8326 and IXC Registration No. TJ777.

IDS holds CLEC Certificate No. 5228 and IXC Registration No. TJ987.

nii holds CLEC Certificate No. 7759 and IXC Registration No. TJ510.

Supra holds CLEC Certificate No. 4861, PATS (pay telephone service company) Certificate No. 5922, and IXC Registration No. TK091.

The Companies, however, no longer provide telecommunications services in Florida following the completion of the migration of the Companies' customers and its telecommunications network to Birch Communications on August 25, 2009.<sup>1</sup> The




