The Solid Waste Authority (SWA) is a dependent special district created by the Florida Legislature under the Palm Beach County Solid Waste Act, Chapter 2001-331, Laws of Florida (the Special Act), as a political subdivision of Palm Beach County, Florida. The Special Act authorizes the SWA to construct and operate resource recovery waste-to-energy (WTE) facilities
