Staff is requesting permission to make a minor oral modification to Item 7; the language merely provides clarification and does not alter staff's recommendation. Staff requests that the following language be inserted after the third full paragraph on page 5, immediately before the conclusion section:

Staff notes that the addition of Okeechobee County to the proposed tariff's description of the territory served only represents a notice from the Utility that it intends to provide service in that area. FPUC currently has no firm contracts for service in the area. Staff therefore recommends that any order approving the proposed tariff include language noting that Commission approval does not convey any exclusive territorial rights to the FPUC utility for that county, nor does it preclude another utility from challenging FPUC's right to serve Okeechobee County under Section 366.04(3), F.S. and Rule 25-6.0441, F.A.C., when service is requested in the future.
