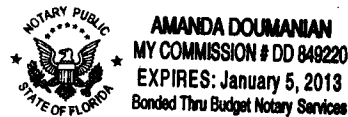

Dear Mr Brise and all agents, officers, employees, contractors and interested parties,

We, The People, of The State of Florida, with the power vested in us via The State of Florida and the national united States of America Constitutions, especially as these pertain to—a) all rights not outlined in the Constitution are expressly reserved by We, The People; b) the 4th Amendment, whereby We, The People, are entitled to rights of privacy; c) the 5th Amendment, whereby We, The People, are entitled to due process and a proper hearing on any matter that invokes reasonably related injury; and d) the 11th Amendment, whereby when people in governmental positions become tyrannical against We, The People, they themselves become individually responsible for criminal behavior and cannot hide behind their feigned governmental protection—hereby notice per the above-referenced NOTICES, NOTICES OF NO CONSENT, NOTICE OF DEFAULT AND NOTICES AND DEMANDS, our demand for a moratorium on Smart Meters, the Smart Grid and their entire installations and operations. In other words, We demand a moratorium on the entire Smart Grid itself, which threatens the power (wired, electrical) grid, without limitation by way of the Smart Grid's considerably increased draw and consumption of energy from off of the power grid, and by its threat of hackability and cyber-insecurity to the power grid. This wireless, irradiating grid must be turned off and eliminated in its entirety. There is no negotiation. As such, a hearing is more than in order and is hereby noticed and demanded to take place immediately, based on criminal injury to 19,057,542 Floridians. The September 20, 2012 FL PSC Workshop is not a docketed, public hearing and as such is not a service to the public: indeed, it is a disservice. The harm to be produced to the public by the said Workshop is evident, without limitation, in the proponents' formation and control of the agenda, without allowance of opponents' immediate correction of disinformation, and in the fact that public officials will not be under oath, as We, The People, demand they be. Any refusal of these Demands will be considered continued default (see first Default in "RE:" section, above) by the PSC and its individual board members and legal counsel; since this pertains to criminal activity including without limitation wiretapping, which is a felony.

We, The People, hereby demand that Pam Bondi, become the Intervenor, as was done just recently in Michigan to protect US from Smart Meters, the Smart Grid and its installations and operations.

We, The People, forbid, refuse and deny consent of any installation and/or operation of any Smart Meter or Smart Grid in The State of Florida and Notice you of criminal injury to 19,057,542 Floridians by said scheme and Demand an immediate hearing for the immediate termination, shutting off and disassembly of said Smart Meter and Smart Grid and its installations and operations throughout the entire State of Florida.

We, The People, place on Notice that all persons, people, government agencies and private or public organizations responsible for installing and/or operating said Smart Meters and Smart Grids in The State of Florida have, are and will continue to be fully liable for any injury, harm, violation, intrusion or negative consequence caused or made "reasonably" possible by Smart Meters, the Smart Grid or its installation or operation thereof. If any or all Notices, Notice of No Consent, Notices of Default, Notices and Demands, et alia, are ignored by any or all Automatic Recorders, Board Members of the PSC and/or its Counsel, We, The People, plan to file a lawsuit against the appropriate agencies, organizations, people, et alia. If this action is required by We, The People, we plan to demand grand trials by jury in all 67 Counties in The State of Florida and We, The People, will not stop until injury by Smart Meters, the Smart Grid and their installation and operation ceases in entirety.

The document here presented contains legal and lawful Notices, Notices of No Consent, Notice of Default and Notices and Demands. After this delivery the liabilities listed above may not be denied or avoided by parties named and implied herein. Again, Civil Servant immunities and protections do not apply to the installation or operation of Smart Meters and the Smart Grid due to the criminal violations they represent. Please govern yourselves accordingly.

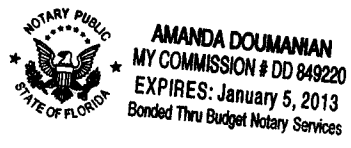

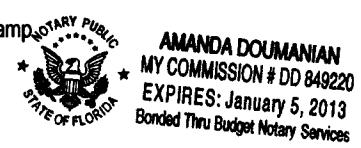

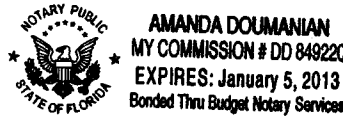
