Control rack to be constructed with 6"X6" concrete posts and galvanized Unistrut, Conduits to be Sch. 80 PVC.

CL2 pump, pressure switch and well pump to be wired into new control panel.

Control panel description:

100 amp main breaker, starter with thermal protection, phase protection, HOA switches and indicator lights for the submersible pump and CL2 pump, GFI receptacle and CL2 pump to be on their own 20 amp breakers, elapsed run time meter, all housed in a painted steel enclosure.
