**RESPONDENT FLORIDA POWER & LIGHT COMPANY'S  
RECORD SUPPLEMENT**

Respondent Florida Power & Light Company ("FPL") provides this Record Supplement for inclusion in the record in this proceeding.

In 2011/2012, FPL completed a survey of the joint use poles subject to the Joint Use Agreement between FPL and Verizon Florida LLC ("Verizon"). Verizon received the results of that survey.<sup>1</sup>


A summary of the results of that survey as to the average number of attaching entities on each joint use pole and the average pole height of each joint use pole is shown on the following chart. The summary chart and the underlying survey data serve to complete the record before the Commission with the best facts available to both parties on the issues of the average number of attaching entities and average pole height.


