Dear Sirs,

Utilities, Inc of Florida's (UIF) proposed rate consolidation & rate increase, which is before the Public Service Commission (Docket No. 160101-WS), is not in the "best interest" of the future direction of the City of Longwood, Seminole County, the 29,000* customers & Citizens of Central Florida, nor the remaining 31,000* current Statewide Customers of UIF. (*- 60,000 Equivalent Residential Connections (ERCs)..see "Footnotes" at the bottom of this email).

This is evidenced during Mayor Durso's District 2 report at the last Commissioner's Meeting (held Feb. 20, 2017), in which it was stated that he wanted to:

- o "...direct City Staff to place this topic on the Agenda..."
- o "...develop resolution & support for cause against what is about to happen...";
- "...get on-board with whatever opposition the county is presenting and other municipalities are presenting..."

Seminole County has stated in a letter sent to the Public Service Commission (Written Feb. 17, 2017; Filed Feb. 23, 2017), of its "...objection..." to the proposals due to the 70% increase in bulk water costs, which would have to be passed onto the Residents of the County that are supplied by Seminole County. (See attached pdf: 17-02-17 - Seminole County Board of County Commissioners)

Pasco County and the Summertree Community has been in protracted disputes (Primary & Secondary Water Quality issues, coupled with non-stop rate hikes, despite unresolved water quality issues) with UIF for several years, and recently moved Summertree's service from UIF to Pasco County. FL Senator Wilton Simpson, State Representative Richard Corcoran, & Pasco County Commissioner Jack Mariano were all involved with these disputes, as well as this latest proposal by UIF. Of particular interest, is Commissioner Mariano's submission (via Secretary to the [Pasco] County Commissioners) to PSC in a letter dated October 6, 2016, in which he states "...In my opinion, they should have their licenses revoked..." and goes on further "...It is unfortunate that this private Utility has failed these residents. I, personally, intend to do everything in my power to see to it that this Utility is brought into public ownership..." (See attached pdf: 16-10-10 - Pasco County Commissioner Mariano comments)

I am certain that other communities & Counties have also had their share of issues with UIF. This latest proposal, with rate hikes ranging from 70-109%, is just the latest in a long string of rate hikes. As such, the current Customers of UIF, under the Leadership of Ann Marie Ryan, have formed "Florida Consumer Water/Wastewater Alliance (FCW Alliance)", and support the City of Longwood's opposition to the UIF proposal. Ann Marie, who is also in a Leadership position for Summertree Water Alliance (SWA), has been successful in holding UIF's "feet to the fire" and mobilizing Summertree's residents in opposition to prior proposals brought before the Public Service Commission (PSC). As such, FCW Alliance respectfully requests that the City of Longwood support our efforts in UNITING ALL 60,000* UIF CUSTOMERS in a dual strategy by:

1. <u>UIF Customers, County & City officials join together to oppose Docket No. 160101-WS, UIF Consolidated Rate</u> Case:

- Drafting and approving a "Letter of Support" for FCW Alliance efforts to unite UIF customers in opposition to Statewide consolidation
- Drafting and approving a "Letter of Opposition" to UIF's proposal (Docket No. 160101-WS)
- Filing such letters with: Commission Clerk, Florida Public Service Commission, 2540 Shumard Oak Boulevard, Tallahassee, FL 32399-0850
- Request a "courtesy copy" of these letters be sent to: Florida Consumer Water/Wastewater Alliance, 11436
 Windsor Court, New Port Richey, FL 34654

2. Help to effect Legislative Reform:

• The groundwork for this action has already begun. Please reach out to our Elected State Representatives to speak with Fla. Senator-Wilton Simpson and Fla. Footnotes:

*All notations regarding the number of customers is based upon "Equivalent Residential Connections" (ERC's).

- Statewide: UIF has about 60,000 combined water and wastewater equivalent residential connections (ERCs). Some customers receive both wastewater and water service from UIF (i.e. 1 customer = 2 ERCs) and some customers place greater demand on UIF services (i.e.- a large condo customer with large water meter might equal 20 ERCs, but be one customer). According to Office of Public Counsel, there are about 44,000 Customer Accounts.
- **Sanlando, Seminole, and Longwood**: According to the Office of Public Counsel, the number of <u>monthly bills sent</u> to residential customers and general service (commercial) customers:

	Water	Wastewater
Sanlando	10,448	9,726
Seminole County	2,574	1,382
Longwood	n/a	1,619
Total	13,022	12,717

Note: some customers are water only, wastewater only, or both.

Dear Commissioners:

Seminole County (the "County") is a wholesale customer of Utilities, Inc. of Florida (the "Utility"). The County purchases water and wastewater services from Sanlando Utilities Corporation, which is owned by the Utility. The County hereby objects to the above referred to increases proposed for the residential, general and flat rates charged to the County as a direct customer; and also those increases proposed for customers of the Utility who are private Seminole County residents.

Based upon the Fiscal Year 2016 payments the County has made to the Utility as a wholesale customer, the County would pay an additional \$279,000 more per year on all of its accounts to the Utility; an increase of over 70%. The majority of the increase is from the Sanlando area serviced by the Utility that is billed to the County on a flat rate per the ERC method for wastewater treatment. The amount the County would pay would increase from \$326,124 to \$544,236 per year. Based on FY2016 County expenditure information for the remaining five (5) other accounts with the Utility, the proposed increase would cause County costs to rise from \$57,000 to \$117,645.

Increases of this magnitude are well beyond what the County would reasonably anticipate and are beyond any reasonable assumptions the County has used for creating and maintaining rates within its five-year plan. If these increases are approved, they would shock the County's customers if they were passed on. The County is placed at a significant disadvantage by this level of increase. It does not have the ability to pass-through the rate increase without undertaking a formal rate adjustment hearing which would undoubtedly receive significant customer disapproval. Of course, the County would be susceptible to the claim of providing an illegal subsidy if it did not follow the appropriate procedures that would directly pass the costs through to the customers.

The County is also concerned that its citizens who are direct customers of Utilities, Inc. will not be able to pay this exorbitant rate increase. Increases of over 100% are proposed for some residents. These increases are just not able to be absorbed by many customers, especially those on fixed incomes.

Charging consolidated rates would be easier for the Utility to manage; but imposing a uniform rate over disparate cost utilities will cause many of our customers in Seminole County to subsidize the rates for other customers of the Utility in other parts of the state. It is hard to understand the equity of charging a consolidated rate when the company continues to bill separately. Separate billing mechanisms are in place for each company within Utilities Inc. That method facilitates the allocation of fair costs and does not unjustly increase the costs to low-cost system customers in a discriminatory manner.

Thank you for your consideration of this objection and we look forward participating in this proceeding to protect the interests of the good citizens of Seminole County.

Honorable Members of the Florida Public Service Commission:

On behalf of Pasco County and residents of Summertree, I would like to share some insight on the case currently before you. For nearly twenty (20) years, the residents of this community feel they have been dealing with a company that never once operated with their best interests in mind. The facts are compelling – they have continually pumped and distributed some of the worst quality water from their wells to profitably sell it on the backs of these residents. In my opinion, they should have their licenses revoked. Utilities, Inc. now stands before you seeking approval of an interconnect with Pasco County and possibly a rate increase.

The residents themselves have spent over \$16,000 of their own money to push this initiative forward, while Utilities, Inc. of Florida attempts to find new ways to nickel and dime these folks to death. Should this not be a consideration of the PSC when determining which course of action is proper? Furthermore, Utilities, Inc. of Florida, through its spokesman, Mr. Patrick Flynn, attempts to mislead the PSC by not presenting all of the facts. One such example was during the last hearing on September 13, 2016, when Mr. Flynn stated that Pasco County had not completed the design for the interconnect and thus giving the impression that this project is not ready to move ahead. In fact, the week prior, on September 7, 2016, to be precise, Mr. Flynn indicated in an email that he had no further comments on the design. At that point, the design was deemed complete, and Pasco County was ready to move forward with construction within the coming weeks.

It is unfortunate that this private Utility has failed these residents. I, personnally, intend to do everything in my power to see to it that this Utility is brought into public ownership; however, until that time, I ask that you strongly consider the testimony of the residents and the professionals from Pasco County, here present, on October 11, 2016, as you decide how to best handle this case.
