Not sure why the CMS doesn't draw data directly from the MCD, but the utility listed should match the MCD, so

For Docket 170044-TX

The utility should be listed as Network Telephone, LLC; those other versions of the name can be deleted from the CMS, also the MCD leaves out the comma in the utility name.

And I should have caught it when I asked for the revision, but the docket title leaves out the “,LLC” part from the name that is being changed:
