a homeowner on Little Gasparilla Island, I am writing to ask you to deny the application for sewer/wastewater certificate and a waiver of Rule 25-30.033 (1)(p) and (q) by Environmental Utilities. We have just been notified by mail and very strongly object to the granting of a temporary waiver of Rule 25-30.033 (1) (p) and (q). Stakeholders have no information of the financial status of this newly established company, nor of the owners status, since all financial info is being kept confidential! Since this will obviously be a huge financial venture on the part of the homeowners, this is unacceptable! We need to have transparency of all relevant info regarding the project including the proposed rates, connection fees, and the type of system to be installed! Questions that need to be answered are very important. How many projects has this EU company completed? Any? How many employees does the company have? Has the applicant provided the required detailed financial statement as asked for by the PSC? Since the cost of the project has not been determined yet, how are stakeholders to know if the applicant has the required finances personally, is even able to secure a loan or to provide the on going maintenance that will be required? Why are there no projected costs of the project given? Word of mouth as heard by homeowners from Mr. Boyer like, "Probably \$20,000 for the barrier islands, maybe \$19,000, for Cape Haze and maybe grants are available " is not adequate, How can stakeholders agree or protest is we do not have adequate information?

I formally request that the motion to bifurcate and temporary waiver be denied.
