St. Joe Natural Gas Company, Inc. ("SJNG") by and through its undersigned officer, hereby submits its Preliminary List of Issues and Positions to be taken up at the Hearing now scheduled to begin **November 1, 2022** in the above listed docket.

**Issue 1:** What are the final conservation cost recovery adjustment true-up amounts for the period January through December **2021**?

**SJNG's Position: \$23,184 under-recovery.**

**Issue 2:** What are the appropriate conservation adjustment actual/estimated true-up amount for the period January through December **2022**?

**SJNG's Position: \$ 56,534 over-recovery**

**Issue 3:** What are the appropriate total conservation adjustment true-up amount to be collected/refunded from January **2023** through December **2023**?

**SJNG'S Position: \$79,718 over-recovery**

**Issue 4:** What is the total conservation cost recovery amounts to be collected during the period **January 2023** through **December 2023**?

**SJNG's Position: An Under-recovery of \$114,907.**

**Issue 5:** What are the conservation cost recovery factors for the period January **2023** through December **2023**?

**SJNG's Position: \$0.27254 per therm for RS-1, \$0.19097 per therm for RS-2, \$.14851 per therm for RS-3, \$.09512 per therm for GS-1, \$.05337 per therm for GS-2, and \$.04049 per therm for FTS-4.**

**Issue 6:** Should the Commission approve revised tariffs reflecting the natural gas conservation cost recovery amounts and establishing natural gas conservation cost recovery factors determined to be appropriate in this proceeding?

**SJNG's Position:** Yes


**Issue 7:** What should be the effective date of the new conservation cost recovery factors for billing purposes?
