6	MR. PREWETT: Good morning, Commissioners. I
7	am Devan Prewett with the Division of Economics.
8	Item 15 is a joint petition by the City of
9	Lakeland and Tampa Electric Company requesting
10	approval to provide temporary retail electric
11	service to two real estate parcels, each one
12	located in the other utility's service territory.
13	This request is necessitated by developer time
14	constraints and the joint petitioners' time
15	requirements for evaluating all boundary changes
16	and producing the requisite boundary maps.
17	The joint petitioners intend to file a
18	territorial agreement with the Commission on or
19	before June 30th, 2025, that, if approved, would
20	convert the requested temporary service to
21	permanent service.
22	Staff recommends the Commission conditionally
23	approve this joint petition, noting that the joint
24	petitioners represent that no uneconomic
25	duplication of service would result from the

1	proposed extensions, no customers will be
2	transferred, and no service reliability issues are
3	expected to occur for either utility.
4	Staff recommends that the joint petitioners be
5	required to either file a territorial amendment by
6	June 30th, 2025, or, if they cannot do so for a
7	good reason, report by that date when they will
8	make such a filing.
9	Representatives of the joint petitioners are
