To the PSC Staff,

My husband and I are building a home on Palm Island and are dismayed and opposed to the idea of sewer systems being proposed for the island. The potential environmental damage to wildlife, plant, & aquatic life to the island would be catastrophic. We chose this particular island due to how dedicated the residents are as stewards of the wildlife that lives here. We stand alongside the residents in wanting to protect the future of all the creatures that live on the island for generations to come. With the threat of putting in sewer systems, the potential for sewer discharge and leaks would be devastating for tortoises, seas turtles, manatees, dolphins, fish, mangroves, and the balance of the unique ecosystem currently thriving on the island. Irreparable damage to wildlife, plant, & aquatic life could throw the entire ecosystem out of balance which would have far reaching outcomes.

Another concern is the possible introduction of pathogens and health risks for anyone visiting and/or living on the island. Given Florida has so many tropical storms & hurricanes, low-pressure sewer systems are highly susceptible break down or stop working which will result in a health risk with un-flushable toilets likely for days before anyone can gain access to the island to service the numerous homes and condos. The risk for sewers to fail and contaminate canals & bays is too large a risk to wager.

The proposed hook up fees, permitting, barge fees, and monthly water billing all prohibitive. Charlotte County works with an affordability rate of no more than \$113/mo for wastewater for all Charlotte County residents. There will be equipment failures and given just one ferry that doesn't operate in weather conditions.

It's time to make a different choice, one that prioritizes protecting nature, the animals we get to share this earth with who are depending on us to make good decisions. I am asking you to be stewards for wherever you happen to live, for Palm Island, for Charlotte County, for Florida, and be an example for the rest of the United States. I am writing as a home owner on Little Gasparilla Island to voice my strongest possible opposition to the above docket for a sewer system on the Bocilla barrier Islands. There is absolutely no need for this system as no problem exists with the current management of sewage on these islands and the overwhelming majority of homeowners oppose it. In the words of President Reagan, "If it ain't broke, don't fix it". This proposal is a money making scheme for the FOR PROFIT Environmental Utilities who have NO experience with such a system. The costs would be passed on to us owners and is estimated to cost each home owners in excess of \$40,000, plus monthly fees once in place. They are proposing an outdated low pressure technology that Charlotte County won't install any more because of the excessive cost to maintain. These have a high failure rate and spillage of raw sewage into our delicate island and intracoastal environment will be disastrous for wildlife, the fisheries and tourism. Construction fo this system will be very disruptive to the island residents. These are bridgeless islands and access is dependent on a ferry which does not operate on a regular schedule. If there is an emergency with the sewage system, access to repair it will be slow in arriving.

This system will be an undue burden on homeowners: each homeowner will have to provide electric permits and service as well as a generator for the frequent power outages on the island. We would also have to give away 15' of property for an easement. Also, there is no oversight for this

project, no performance bond required and we have no single point of recourse in the event of cost overruns or project failure.

Hello

I am writing urging you reject this application. I am currently building a home at 8904 Gulf Street and own a condo at hideaway bay beach club 9400 little Gasparilla Island, A8.

I spoke at the commissioner meeting in January against this project. No need has been established, the costs are excessive, their technology is outdated there would be damage to the environment, and easements would be mandated (many lots on LGI are 50 by 100 feet with little to no room to spare for additional easements) to name a few of the many issues.

I am permitted to install a performance based automated unit at the total cost of \$50,000 later this year. It is the highest standard of automated units which is required to have testing twice per year and even more in the early phases of set up. It is superior to the system EU is proposing in every way but if this passes I would be forced to dig out and remove this brand new superior system at my own cost and be forced to spend 40k to hook up to EU's system. As I'm sure you're aware, we live on a barrier island with no bridges and have to barge everything over which greatly increases the cost of everything we do.

It is highly unfair that we have to pay for a new septic system and then be forced to tear it out within a year or two in order to accommodate a sewer system that we do not want nor need and also fear. And, there are many others in this same situation. Island-wide fear is due to the lack of effectiveness of the kind of system being proposed, the time it will take to complete along with the interruptions to our right for the peaceful enjoyment of our property. The destruction to our island will compound the devastation already inflicted by the recent hurricanes. In addition, the estimated costs are going to far exceed the estimate presented by the applicant and does not include the upgraded electrical system that each home or property will be required to provide.

And then, God forbid, what will happen should there be another storm the magnitude of Ian, Helene or Milton. What will happen each time the power goes down on the island (which most recently went down for the entire day on March 24th) and happens often? What is the plan for another catastrophic storm surge? Who will be responsible for the damage to property owners due to efluence escape?

The majority of the people on the island do not want this and the very few in favor appear to have personal reasons: either they are related to the applicant, good friends of the applicant or stand to benefit from the approval of the subsequent project.

As I said, I attended and spoke at the hearing and nearly all were against it.

The testimony that I found most appalling, and also quite interesting, was from the gentleman who stated that he had been offered to buy this sewer system for eleven million dollars. Why would he say this if it wasn't true? With all due respect, this has shade of backroom shenanigans.

I am disappointed (and quite honestly, disgusted) should there have been any sort of back room positioning in order for persons to make money off the backs of people who have already been through several traumatic, damaging and expensive experiences since 2021, some losing everything with no federal, state or local help.

There has been no evidence presented of environmental damage to sensitive areas that surround our beautiful island. The current systems in place to the north, south and east of us all had major problems due to the fact that the systems did not perform as planned during and after these recent storms, subsequently wreaking havoc with overflow waste flowing into and onto private property, not to mention the surrounding waters.

I would ask you from the bottom of my heart to deny this application due to the following:

- 1. The applicant is not qualified to install and operate the planned system.
- 2. He (jack boyer) has expressed to others the plans to sell the "slam drunk" project to enrich himself, and has stated to others that this is "his retirement plan".
- 3. 95% of the community opposes this application.
- 4. Most owners are not able to afford it and will have to sell which, in all likelihood, will create a "land grab" by those who wish to change one of the last, beautiful vestiges of Old Florida... for personal monetary gain.
- 5. Many owners will refuse to give an easement or right of way which will result in long, embroiled and acromonious lawsuits.
- 6. To add insult to injury, should this be forced upon us, we will be obligated to pay monthly fees for the "privilege" of having this unwanted atrocity after being strong-armed to fund it in the first place.
- 7. The likelihood of unforeseen mishaps due to the nature of our unique island, and the lack of the adequate infrastructure to support such a fiasco, would surely reap dire consequences to our surrounding environment, not to mention our individual homes and land.

Hideaway bay beach club was excluded from the scope of this project in May of 2024. It came to light in January of 2025 that the Waste water Transmission line for LGI is being brought over to HBBC property. This has the potential of completely closing down our property if a pump house is built on our septic drain field. We have been denied our due process. Our lawyer's letter was ignored when the PSC staff made their recommendation to approve the application.

I have 2 dogs on this fight and this application negatively effects both of my properties immensely. Thank you for taking the time to read my letter.

PLEASE DENY ENVIRONMENTAL UTILITY'S APPLICATION

My husband and I are full-time residents on the sparsely populated, salty piece of land known as Little Gasparilla Island. We built here over 20 years ago, when there were about 40 full-time residents and a small transient population. Today, there are approximately 120 full-time residents. In the past two decades, there has been very little growth. The island's total capacity is only about 450 possible Equivalent Residential Connections (ERCs), and that number will not change unless an unnecessary central sewer system is imposed upon our community. Nearly 70% of stakeholders oppose this application.

I have carefully reviewed the Environmental Utility's (EU) application, all the briefs, testimony, and attended two days of hearings, listening to attorneys and expert witnesses. There was no demonstrable need for this service. If a few family members and developers are enough to justify the imposition of a central sewer system, this would be an absurd decision.

Please, DO NOT MAKE THE SAME MISTAKE as the Charlotte County Commissioners, who supported EU's application without due diligence. Charlotte County did not conduct any impact studies, neglected the needs and rights of homeowners, and failed to assess the water quality of Little Gasparilla Island's surrounding waters. The "resolution of support" was composed by EU's attorney and merely rubber-stamped by the commissioners, as requested by a private, for-profit individual. This is a clear dereliction of duty to the citizens they are supposed to serve and protect, leaving 800 residents to fend for themselves.

Commissioners Clark, Graham, and Passidomo-Smith, you have seen more evidence on this case than our local commissioners, who were absent during the hearings. They have not taken the time to hear, see, or witness the testimony of their constituents. This is not the first time they have failed to represent us adequately.

Our island is surrounded by a state-designated Outstanding Florida Water body. We want to protect, preserve, and improve it. A central sewer system is not the solution. We cannot risk sewer pipes beneath our sandy paths and through our bay and intracoastal waterway. The possibility of untreated wastewater spilling into our waters and onto our property is unacceptable.

While some septic systems on the island may need repair or replacement, this does not justify a blanket, astronomically costly mandate for the entire community. Viable solutions, such as Enhanced Nutrient Onsite Sewage Treatment Disposal Systems (ENR-OSTDS), are being considered by the Florida Department of Environmental Protection possibly as better alternatives than septic to sewer conversions for coastal communities.

PLEASE GIVE US A CHANCE

Give us a chance to preserve our homes. Give us a chance to protect our fragile environment. Give us a chance to explore better systems and funding where needed. Give us a chance to maintain our peaceful community.
