## <u>PETITION OF FLORIDA CITY GAS</u> <u>REQUESTING APPROVAL OF AN UPDATED AFUDC RATE</u>

Florida City Gas ("FCG" or "Company"), by and through its undersigned counsel, hereby

files this Petition seeking approval by the Florida Public Service Commission ("Commission") of

an allowance for funds used during construction ("AFUDC") rate of 7.72%, in accordance with

Rule 25-7.0141(5), Florida Administrative Code. The Company's AFUDC rate was last set in

Docket No. 20230108-GU. In support of this request, FCG states as follows:

In support of this request, the Company hereby states:

1. FCG is a natural gas distribution company subject to the Commission's jurisdiction under

Chapter 366, Florida Statutes. Its principal business address is:

3. The Commission is vested with jurisdiction in this matter in accordance with Sections 366.04, 366.041, 366.05, and 366.06, Florida Statutes, which authorize the Commission to establish rates and charges for public utilities, including the relief requested. The Company is unaware of any material facts in dispute at this time, but the proceeding may involve disputed issues of

material fact. The Company's request set forth herein does not involve reversal or modification of a Commission decision or proposed agency action. This is a Petition representing an initial request to the Commission, which is the affected agency located at 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399.

- 4. In accordance with Rule 25-7.0141(5), F.A.C, the Company has provided Schedules A through C, calculated in accordance with Rule 25-7.0141(3). These schedules identify the capital structure, capital structure adjustments, and methodology used for the calculation of the monthly AFUDC rate.
- 5. AFUDC is an accounting entry designed to permit a utility recovery of the cost associated with financing eligible construction activities, rather than a tariffed rate or charge.
- 6. The AFUDC rate proposed herein is based on the actuals for the 12-month period ending December 2024. Therefore, in accordance with Subsection (6) of Rule 25-7.0141, FCG requests that the AFUDC rate of 7.72% (0.621742% monthly) be approved with an effective date of January 1, 2025.
- 7. The Company will continue to monitor the cost of capital for material change and request a change in rates when appropriate.

WHEREFORE, Florida City Gas respectfully requests that the Commission approve its request to update its AFUDC rate.
