## **PURPOSE AND PROCEDURE:**

The purpose of this hearing is to determine whether the transmission and distribution storm protection plans should be approved, approved with modification, or denied pursuant to Section 366.96, Florida Statutes (F.S.), and Rule 25-6.030, Florida Administrative Code (F.A.C.), as submitted by Florida Power & Light Company, Duke Energy Florida, LLC, Tampa Electric Company, and Florida Public Utilities Company. The Commission may also consider any motions or other matters that may be pending at the time of the hearing. The Commission may rule on any such motions from the bench or may take the matters under advisement. This proceeding shall: (1) allow the parties to present evidence and testimony in support of their positions; and (2) allow for such other purposes as the Commission may deem appropriate.

At the hearing, all parties shall be given the opportunity to present testimony and other evidence on the issues identified by the parties at the prehearing conference held on Monday, May 5, 2025. Each witness shall be subject to cross-examination at the conclusion of their testimony.
