On April 8, 2025, Florida City Gas (FCG) filed a request for confidential classification of Document No. 02698-2025. This document contains certain information in the proposed transportation service agreement with Miami-Dade County, which FCG identified as confidential. Specifically, FCG identified the Deposit on page 4 of 21 and page 16 of 21. They also identified the Tiered Rates on 16 of 21, the Minimum Annual Volume, Maximum Annual Contract Quantity, and the Maximum Daily Contract Quantity all on page 17 of 21. Furthermore, FCG explained in its request for confidential classification that both FCG and Miami-Dade County treat the information as proprietary confidential business information that is not otherwise available in the public domain.

Staff reviewed the document and concurs with FCG that the nature of the information meets the requirements set forth in Sections 366.093(3)(d) and (e), Florida Statutes, whereby disclosure of the information would harm the competitive business operations of FCG. Therefore, staff recommends that the request by FCG for confidential classification of Document No. 02698-2025 be approved.
