Pursuant to Section 366.093 of the Florida Statutes, and Rule 25-22.006, Florida Administrative Code, Florida Power & Light Company (FPL) requests confidential classification of certain information in DN 01203-2025 concerning the petition by FPL for Base Rate Increase.
