Pursuant to Section 366.093 of the Florida Statutes, and Rule 25-22.006, Florida Administrative Code, Florida Power & Light Company (FPL) requests confidential classification of certain information in DN 01274-2025 concerning the petition by FPL for Base Rate Increase.

Based on staffs review, the information provided that is related to the petition by FPL for Base Rate Increase contains competitive business information regarding corporate income taxes, the disclosure of which would impair FPL, or its vendors, to enter transactions for services on favorable terms. Therefore, staff recommends that the request for confidentiality of certain information included in Document No. 01274-2025 be approved pursuant to Section 366.093(3)(e), F.S.
