Pursuant to Section 366.093 of the Florida Statutes, and Rule 25-22.006, Florida Administrative Code, Florida Power & Light Company (FPL) requests confidential classification of certain information in DN 01787-2025 concerning the information provided in response to OPCs 1<sup>st</sup> set of interrogatories and 1<sup>st</sup> request for PODs.

Based on staff's review, the information provided that is related to the information provided in response to OPCs 1<sup>st</sup> set of interrogatories and 1<sup>st</sup> request for PODs contains information concerning bids or other contractual data, the disclosure of which would impair FPL, or its vendors, to enter transactions for services on favorable terms. Therefore, staff recommends that the request for confidentiality of certain information included in Document No. 01787-2025 be approved pursuant to Section 366.093(3)(d), F.S.
