On June 30, 2025, Peoples Gas System, Inc. (PGS) filed a request for confidential treatment of Document No. 05335-2025. This document contains PGS's integrated resource plan, technology roadmap, and pipeline insights approval documents.

In its request for confidentiality, PGS contends that the document contains trade secrets, as well as information concerning competitive business interests, the disclosure of which would impair their competitive business. PGS also contends the document contains information that constitutes security measures, systems, or procedures in the form of Critical Energy Infrastructure Information, the disclosure of which could compromise PGS's security interests. Furthermore, PGS asserts that it treats the highlighted information provided in Document No. 05335-2025 as private and has not publicly disclosed it.

Staff has reviewed the document and concurs with PGS that the nature of the information meets the requirements set forth in Section 366.093(3) (a), (c), and (e), Florida Statutes, whereby disclosure of the information would impair its competitive business interests. Therefore, staff recommends the request by PGS for confidential classification of Document No. 05335-2025 be approved.
