FLORIDA POWER & LIGHT COMPANY'S REQUEST FOR CONFIDENTIAL CLASSIFICATION OF INFORMATION PROVIDED IN RESPONSE TO THE STAFF OF THE PUBLIC SERVICE COMMISSION'S SIXTH SET OF INTERROGATORIES (NO. 14)

Pursuant to Section 366.093, Florida Statutes, and Rule 25-22.006, Florida Administrative Code, Florida Power & Light Company ("FPL") hereby submits its Request for Confidential Classification of certain information provided in its response to the Staff of the Public Service Commission's ("Staff") Sixth Set of Interrogatories (No. 14) ("Confidential Information"). In support of its Request, FPL states as follows:

- 1. FPL served its response to Staff's Sixth Set of Interrogatories, No. 14 on October 6, 2025. FPL's Response to Staff's Sixth Set of Interrogatories, No. 14, contained information of a confidential nature within the meaning of Section 366.093(3), Florida Statutes.
- 2. This request is being filed contemporaneously with the service of the response to request confidential classification of the Confidential Documents consistent with Rule 25-22.006, Florida Administrative Code.
 - 3. The following exhibits are attached to and made a part of this Request:
 - a. Exhibit A consists of a copy of the confidential document, upon which all confidential information has been highlighted in yellow.
 - b. Exhibit B is an edited copy of Exhibit A, upon which all confidential information has been redacted.
 - c. Exhibit C is a table that identifies the confidential information in Exhibit A and references the specific statutory basis for the claim of

confidentiality and identifies the declarant who supports the requested classification.

- d. Exhibit D consists of the declaration of Michael V. Cashman in support of this Request.
- 5. The Confidential Information is intended to be and has been treated by FPL as private, its confidentiality has been maintained, and its disclosure would cause harm to FPL and its customers. Pursuant to Section 366.093, such materials are entitled to confidential treatment and are exempt from the disclosure provisions of the public records law. Thus, once the Commission determines that the information in question is proprietary confidential business information, the Commission is not required to engage in any further analysis or review such as weighing the harm of disclosure against the public interest in access to the information.
- 6. As explained more fully in the declaration included in Exhibit D, the document provided by FPL contains contractual data, including negotiated terms and pricing information. In addition, the confidential documents contain information relating to competitive interests, the disclosure of which would impair the competitive business of FPL and its' vendors to the detriment of FPL and its customers. Specifically, the confidential documents include fuel price forecasts and agreements for the purchase of natural gas. The disclosure of this information would impair the efforts of FPL to contract for energy related goods or services on favorable terms for the benefit of its customers and would impair the competitive interests of FPL and its vendors. Certain information in these documents and materials would also place FPL at a disadvantage when coupled with other information that is publicly available. This information is protected by Sections 366.093(3)(d) and (e), Fla. Stat.

7. Upon a finding by the Commission that the Confidential Information remains proprietary and confidential business information, the information should not be declassified for at least an additional eighteen (18) month period and should be returned to FPL as soon as it is no longer necessary for the Commission to conduct its business. See § 366.093(4), Fla. Stat.

WHEREFORE, for the above and foregoing reasons, as more fully set forth in the materials and declaration included herewith, Florida Power & Light Company respectfully requests that its Request for Confidential Classification be granted.
